Resolution LU58 #0001 – Proposed Amendments To Local Union Bylaws

Mandated proposed resolution and an update amendment to the Local Union By – Laws of Local 58 to be conducted through a secret ballot vote of the membership in accordance with Section 24.

WHEREAS, the By – Laws of Chauffeurs, Teamsters and Helpers Local No. 58 is not current with the long standing implemented change by action of the Executive Board Officers, to conduct the General Membership Meetings on the fourth (4th) Tuesday of each month.

WHEREAS, the International Brotherhood of Teamsters Office of the General Secretary – Treasurer has mandated the Local Union present an amendment to Section 17 of the By – Laws of Chauffeurs, Teamsters and Helpers Local No. 58 through a secret ballot vote of the membership to increase the minimum threshold for establishing a quorum in order to conduct official union business at regular scheduled General Membership Meetings as identified therein.

NOW THEREFORE, be it resolved by passage of the members in good standing through a secret ballot vote as set forth in Section 17 of the By – Laws. If passed the proposed amendments shall be implemented as follows;

Section 17

MEETINGS

(Update / Housekeeping Change)

(A) GENERAL MEMBERSHIP MEETINGS. General membership meetings shall be held monthly on the ~~third (3rd) Thursday~~ fourth (4th) Tuesday of each month. The Executive Board may change the meeting date in any month, if such change is deemed necessary. In such case the membership will be given adequate notice.

(Mandatory proposed amendment)

(C) QUORUM. The quorum of a general or special membership meeting shall be ~~seven (7)~~ fifteen (15).

All other provisions of the By-Laws of Local 58 shall remain unchanged.


