ABOUT

The Teamsters Joint Council No. 37 Executive Board launched the All Charities Fund in 2024 to support charitable initiatives and educational efforts within the communities our members work and live in. The Funds mission is simple: charity, education, and community engagement.

The All Charities Fund Scholarship reflects our commitment to honoring the hard work of our members by helping their dependents pursue higher educational opportunities. By offering this scholarship, we aim to empower the next generation of leaders who will continue to contribute positively to their communities and beyond.

The All Charities Fund Scholarship will offer eight \$2,000 awards to members of the high school graduating class of 2025.

HOW TO APPLY:

1. Review the Entire Application Packet: Ensure you understand and meet all eligibility requirements.
2. Complete All Sections: Fill out every part of the Application Packet thoroughly.
3. Attach Your Essay, Activities list, and personal statement: Print and include all required attachments.
4. Obtain an Official Transcript: Secure an official high school transcript.
5. Submit Your Application: Mail or deliver your completed application, including the essay and transcript, to our office by Monday, June 2nd, 2025, by 5:00 PM.

APPLICANT ELIGIBILITY REQUIREMENTS

- Be the child, grand-child, or legal dependent of a Teamsters Joint Council 37 member in good-standing for a minimum of 12 consecutive months
 - Member may be active, retired, deceased, disabled, or laid-off
 - At the time of application, the employer that the member works/worked for must be currently signatory to a labor agreement with a Local within Joint Council 37
 - Good-standing as defined in Article X, Section 5 of the International Brotherhood of Teamsters Constitution
 - Financial dependents of members are eligible if the member contributes 50% or more of the applicant's financial support and the applicant is a financial dependent of the Local Union member for federal income tax purposes
 - Retired Local Union members must have been a member in good standing for a minimum of 5 years immediately preceding and prior to retirement
- Be a graduating senior in high school for the 2025 academic school year
- Have a cumulative GPA of 3.0 or higher
- Applicants must be registered to attend an accredited college or university within the United States for academic year 2025-2026
 - Scholarships will be awarded once proof of registration is provided
- Applicants must be registered to take eight credits or more by the beginning of the academic school year
- Children, grandchildren, and legal dependents of officers, organizers, representatives, or employees of Teamsters Joint Council No. 37 and its affiliated Locals are ineligible for the scholarship
- Spouses are not eligible

All applicants are required to submit the following to our office by the deadline of Monday, June 2nd, 2025 by 5:00 PM.

- College Preference
- Activities/ Personal Statement Sheet
- Essay
- Official High School Transcript

AWARD REVIEW / ACCEPTANCE PROCESS

The All Charities Fund Scholarship Committee will carefully review each application packet. Applicants will be evaluated based on the strength of their essay and overall application. Please note that the Committee's decisions are final and cannot be contested.

Scholarship recipients will be notified via mail on or around June 13th, 2025.

The scholarship will be paid directly to your accredited college or university on your behalf. If selected, please provide Teamsters Joint Council 37 with your registration and school information promptly. Failure to do so may result in the forfeiture of the scholarship.

ESSAY REQUIREMENTS / PROMPTS

To be considered for the scholarship, your essay must adhere to the following guidelines:

- Length: 500-700 words
- Formatting: Typed, using Times New Roman font, size 12, and double-spaced
- Submission: Print and attached on a separate sheet of paper
- Topic: Address one of the provided topics
- Please ensure your essay meets all these specifications, as submissions that do not comply will not be considered.

Please choose one of the following essay prompts:

1. Why are Unions important in today's workforce? Discuss the key roles Unions play in protecting workers' rights and improving conditions in the modern labor market.
2. What are some of the major challenges facing workers today, and how do Unions address these challenges? Explain why Union involvement is crucial in tackling these issues.
